Dr. Scott Wade has been Technical & Certification Manager for DALI/DiiA since August 2013, and for around 14 years has been an industry expert member of the IEC 62386 standardisation team. Prior to DALI/DiiA, Dr. Wade was NPI Director for Electronics and Systems at Honeywell ED&S, and prior to that was at Helvar, most recently as R&D Manager for Lighting Controls. Dr. Wade holds a Ph.D. in Power Electronics and M.Eng. in Electrical and Electronic Engineering.

DALI-2 extends and enhances the strengths of DALI as a dedicated, standardized protocol for digital lighting control. Backed by DiiA's certification program with rigorous testing and verification procedures, DALI-2 has a strong focus on multi-vendor interoperability. Also, DALI-2 now extends to all devices in a lighting-control system, bringing standardization to products such as sensors, other input devices, and application controllers, which are the "brains" of a DALI system. Our seminar covers updates to the international DALI standard, and to the DALI-2 certification program. We will also describe new specifications enabling smart LED drivers that can report power, energy and diagnostic data.
