He is also an approved certifier and mandated reviewer of Safety (SEMKO, GS, CB, ETL) & Energy Efficiency in Hong Kong for the international standards in US and EU. Mr Yu is involved in the development of reliability, photometry



and energy efficiency of LED testing (e.g. IEC 62471, US Energy Star, EU ErP Directive, etc.), and provides advisory and consultancy services to manufacturers, local organizations and government agencies regarding the safety and energy efficiency issues of lighting product application, design and development.

The presentation will discuss the latest key regulations and industry standards suppliers, manufacturers and buyers should consider when deciding to export different lighting products to the major markets including North America, Europe, and Asia. The presentation will also introduce lighting product related testing, inspection, and certification services available in Hong Kong.
