To facilitate quicker and effective electricity supply for custom-built booths, Exhibition Services Department kindly introduce RCBO, an innovative electricity supply system, to all raw space exhibitors / contractors.

RCBO with independent socket can protect from electric leakage, fault current and overloaded current. Each RCBO is able to provide 4, 6 or 12 sockets (1500W each), which required Single Phase 30A, Three Phase 15A or Three Phase 30A electricity supply respectively.

Each socket is protected from electric leakage, fault current and overloaded current independently. In other words, electricity supply for appliances in the same circuit with the faulty appliance will not be affected while RCBO would immediately stop electricity supply for the faulty one.

為了更快捷地及有效率地供應電力予自建攤位，展覽服務部誠意介紹一項最新的供電裝置。

RCBO 是一個擁有獨立供電的保護裝置。每個獨立保護的供電裝置可提供 4、6 或 12 個獨立插座(每個上限 1.5 千瓦)，分別提供 30 安培單相、15 安培三相或 30 安培三相的電源。裝置提供每一個插座獨立保護，而不影響同組正常的用電設備。每一個獨立插座會對漏電，故障電流及超出負荷的電流能立即地切斷供電。
